For an enrollee under the Schools of Choice program, class designation in grades 9-12 will be determined based on the number of credits the student has at the time of enrolling in the Summerfield Schools compared with Summerfield School's actual number of credits designated for each grade level. This will determine which grade data is to be applied to your application.

As an enrollee under the Schools of Choice program, 7th - 12th grade student schedules will be determined by meeting with a counselor and having a schedule developed from the specific courses and number of sections available at the time of registration. Summerfield Schools will be under no obligation to create and/or add additional courses or sections.

Under the rules and regulations of the Schools of Choice program, in the event that the number of applicants for a given grade level exceeds the number of designated openings, a random draw system will be held to determine which applications for that particular grade level will be accepted.

In the event a sibling of a Schools of Choice enrollee wishes to enroll in Summerfield Schools in a grade in which Summerfield Schools is accepting students, the sibling will have a priority status in the event the number of applications for that particular grade level exceeds the designated openings.

There will be no tuition or other enrollment costs associated with attending Summerfield Schools. Schools of Choice students will be expected to pay any or all costs that are paid by resident students of Summerfield Schools for supplies, materials, activity fees, etc.

Schools of Choice students will be expected to follow all rules, regulations and policies of Summerfield Schools with particular attention to the district's Codes of Conduct and Dress Codes. Schools of Choice students will also be expected to follow all statutory requirements pertaining to Schools of Choice and all the rules and regulations of the Michigan Department of Education.

As an enrollee under the Schools of Choice program, 10th - 12th grade students athletic eligibility will be determined by the MHSAA Transfer Rule effective the 2023- 2024 school year. Details of the Transfer Rule may be obtained by visiting the MHSAA website at https://www.mhsaa.com/

There will not be any transportation provided by the Summerfield Schools for Schools of Choice students.
