The funds provided to Summerfield Schools will be used to help employees become prepared to teach students during these difficult times and to monitor how students are doing with their academics. We are having our desks spaced out the best that we can, and monitoring if classrooms can stay open, or need to move to remote learning. All staff will receive compensation for this work to prepare their classrooms, lesson plans, and workspaces to accommodate students' needs and provide safe environments. The funds will also be used to compensate building principals who will monitor student academic progress and attendance to identify students needing extra academic support. Funding will also support the wages of a social worker to work with students to address the mental health gaps due to the pandemic.

Summerfield Schools plans to use these funds to help teacher prepare on how to educate students during these difficult times. The summer learning program will be offered to all students for the 2022 summer. Funding will also be used to purchase books and instructional materials to help address student learning loss.

The remaining funds will be spent to make sure that we have enough PPE and custodial supplies to help keep the spread down throughout our buildings. For transportation will monitor student ridership on buses to support spacing out of students to mitigate COVID spread. Funding will be used to purchase security cameras to help monitor temperatures, crowd notifications, remote monitoring of buildings and to assist in contact tracing to keep students, staff and guests safe. Our HVAC/boiler system will also be upgraded/replaced to help improve the indoor air quality in our facilities.
